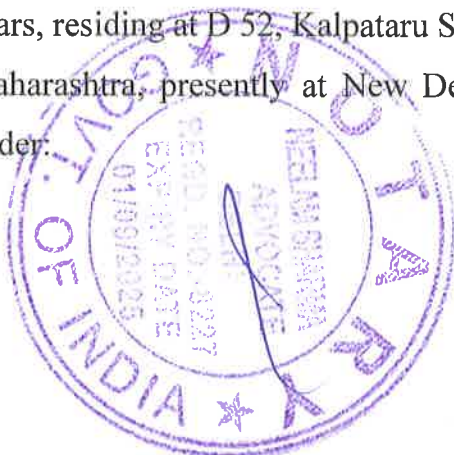

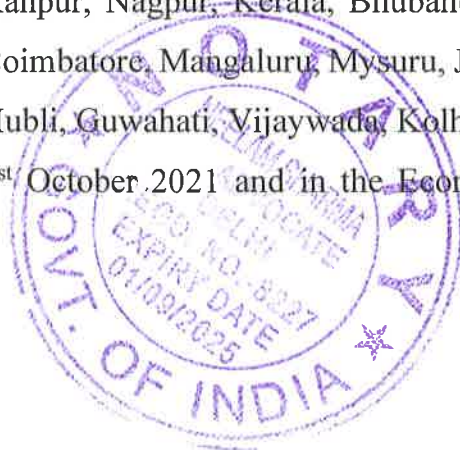

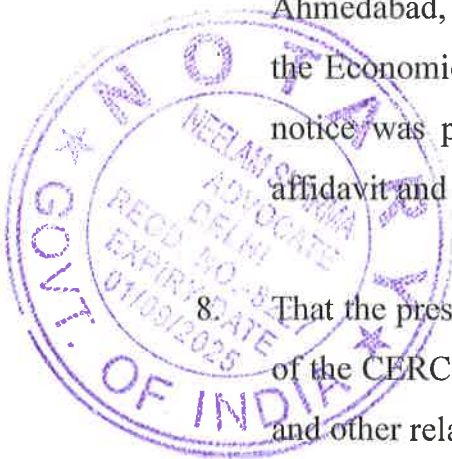

India Set to Become One of the Largest Digital Mkts: Goyal

New Delhi: India is poised to become one of the largest digital markets in the world and the industry can leverage the high-speed Internet to make the country a fintech innovation hub, commerce and industry minister Piyush Goyal has said.

"I believe India is poised to become one of the largest digital markets with rapid expansion of mobile and internet networks," he said, adding that as India aims to become self-reliant, industry and entrepreneurs should use local talent to produce globally marketable solutions.

The minister said under the National Broadband Mission, soon every village in India will have high speed internet and this power can be leveraged to make India a fintech innovation hub.

He said fintech today has the potential to bring investments for mobile apps, e-commerce stores and several other digital infrastructures.

"Investment inflow in the fintech sector, which has gone up to \$10 billion since it started in 2016, has huge potential to up the game, it will simultaneously enhance customer experience. Your strength will be augmented by the world's third largest startup ecosystem, which is hungry for growth," he added.

The minister pointed out that the country's fintech industry came to the rescue of people during the lockdown and the second wave of Covid, promoting contactless banking. Addressing the 2nd Global Fintech Fest 2021 through video conferencing, he said, "At 87%, India has the highest fintech adoption rate in the world against the global average of 64%."

"As of May 2021, India's United Payments Interface (UPI) has seen participation of 224 banks and recorded 2.6 billion transactions worth over \$68 billion and the highest ever, more than 3.6 billion transactions, in August 21," he said.

"Over 2 trillion transactions were processed using the AEPS (Aadhar-enabled payment system) last year," he added.

Goyal said India was today one of the fastest growing fintech markets with more than 2,100 fintechs.

"A lot of Indian fintech markets are unicorns and India's market is currently valued at \$31 billion, and expected to grow to \$84 billion by 2025," he said.

India underwent a digital transformation in mission mode since Prime Minister Narendra Modi announced the Jan Dhan Yojana on August 15, 2014 in his first Independence Day speech after assuming office.

Natural Gas Price Hiked by 62%

New Delhi: The price of domestic natural gas jumped 62% while the price cap for gas from difficult fields jumped 69% in the latest price revision by the government on Thursday.

The new gas price applicable for the next six months through March would be \$2.90 per mmBtu and the price ceiling for gas from deep-sea and high pressure, high-temperature fields would be \$6.13 per mmBtu.

This is a big gain for gas producers such as ONGC, Oil India, Reliance, and BP while it would pose a challenge to consumers. High prices would boost profits for producers, and prompt gas marketers to pass on the increased cost to consumers like fertiliser, power, and city gas distributors.

Prices of piped gas used in kitchens or industries as well as compressed natural gas (CNG) used to power vehicles will rise sharply. Analysts expect city gas distributors to raise CNG prices by about 10%. The rise in domestic gas prices would also boost electricity rates.

Domestic natural gas price, which is derived from a government-set formula that factors in rates from some of the key gas markets in the world, is applicable to most locally-produced gas. Price ceiling for gas from difficult fields is linked to alternative fuels.

Both prices are revised every six months.

After 23 years, Shivna river attains new highest flood level

Aurangabad: Shivna River, a tributary of the Godavari, that flows from Aurangabad district had attained the new highest Flood Level (HFL) of 511.5 m at Latur on September 30 due to the recent spells of heavy rainfall. As per database of the Central Water Commission, the river had a previous HFL of 511.6 m—observed way back in 1968, Jalding Hire, assistant superintendent engineer with Command Area Development Authority of Godavari Marathwada Irrigation Development Corporation (GMDIC), on Thursday said heavy release of water from Shivna-takul medium irrigation project coupled with incessant showers led to Shivna River attaining new HFL.

TMC. The reservoir is already overflowing due to the good run of monsoon during the first half of September. Parineeta Dandekar, associate coordinator at South Asia Network on Dams, Rivers and People (SANDRP), said more such breaches of previous HFL of rivers is possible in Marathwada considering heavy release of water from Manjira and Majalgaon major irrigation projects. Marathwada, which has received 3036.5 mm rainfall since June 1, did not receive any major rainfall activity during the past 36 hours—ending Thursday evening. The lull in rainfall activity has eased out flood situation in many areas where rivers were in spate.

Kolhapur: The dam catchment areas in Kolhapur continued to receive heavy rainfall on Thursday. On the other hand, the city area saw a lull in rainfall after receiving incessant showers over the last five days. Due to the heavy rainfall in dam catchment areas, an automatic gate of Radhanagari dam was opened to discharge 1,400 cusecs water into the Bhogavati river from Wednesday night. The water level in Panchganga river has also increased due to rainfall in the region since the last five days. According to district disaster management officials, Kolhapur district received 6.9 mm rainfall over the last 24 hours, exceeded till 8 am on Thursday morning. Gaganbhavda region received the highest rainfall of 30.1mm followed by 14.9mm rainfall in Shahavadi. Shiraj region received the least rainfall at 1.7mm. With the discharge of 1,400 cusecs water from Gate number 3 of Radhanagari dam to the Bhogavati river, a tributary of Panchganga river and, due to the incessant rains since the last five days, the water level in Panchganga river has started swelling once again. The Panchganga river is flowing at 15 feet at Rajaram Barrage in Kasha Banda area of Kolhapur and two barrages have been submerged under the swollen river water. If the intensity of rain continues, then the river may swell further.

Nashik rain damaged crops on 42k hectares in 2 days

Nashik: Following two days of steady rainfall, the agriculture department's preliminary assessment has been that various crops spread over 42,000 hectares in this north Maharashtra district have been damaged. According to officials, a detailed assessment is being undertaken in the district but talukas like Malegaon, Nandgaon, Veola, etc were the worst hit. Crops have been damaged in other talukas like Nigadi and Dindori in the district. Maize, bajra, onion, soybean, cotton, and other crops were damaged due to the rain. "Crops in Malegaon and Nandgaon talukas have been badly damaged due to heavy rainfall. A majority of the crop damage is in these two talukas," said an agricultural department official on Thursday. The official further said they are already in the process of finalising assessment of crop damage. "Assessment is expected to be completed in the next two-

three days," said the official. Meanwhile, the state agriculture minister Dada Bhuse had a meeting with the agricultural department and Nashik Zilla Parishad on Thursday. He assured farmers that the government will provide assistance. During his visit, Bhuse also directed the agriculture department officials and the administration to file panchnama of crop losses immediately so that farmers would get relief at the earliest. 2nd wettest Sept in 27 yrs cuts monsoon deficit. Naha Madan & Vishwas Mohan 17xv

Pune/New Delhi: Above-normal rainfall this month, which turned out to be the second wettest September in the past 27 years, has almost bridged the deficit of the monsoon season with the cumulative rainfall showing the gap to have narrowed down from 9% on August 31 to just 1% on Wednesday, indicating the four-month season may be logged as 'near-normal' monsoon. With one more day left for the month to end, September has recorded 34% excess rains at 222mm (September 1-29) against a monthly normal of 166.6mm. The last September in terms of monthly rainfall for the country after 1993 was in 2019, when India recorded an excess of 12% during the month. September 2019 had recorded 26.9% excess rain, after which September 2019 and 2021 have received the highest monthly rain. Consecutive low pressure systems over the Bay of Bengal caused September to get excess rains, causing the seasonal monsoon rain for 2021 to touch the near-normal level despite a deficient August. India's monsoon rain till September 29.

Supply hit, veggie prices soar

Nashik: The retail price of various vegetables in the city have soared as the rains have adversely affected the supply. The vegetable prices in the retail markets have increased between 20% and 30% in the last few days. According to Nashik Agricultural Produce Market Committee (APMC) officials, the supply of the vegetables has been reduced by 30% in the wholesale markets, leading to a rise in vegetable prices in retail markets.

Even the prices of vegetables have increased in wholesale markets following a drop in supply of vegetables as compared in the demand. The retail prices of tomatoes have doubled from Rs 20 to Rs 40 per kg, while onion price has increased to Rs 30 a kg from Rs 20 a kg last week. The prices of tomatoes had dropped excessively in wholesale markets during the last one-and-a-half months. 8-storey building collapses in Shimla

Shimla: An eight-storey building collapsed at Doda Chowki area of Shimla district Thursday evening, no loss of life or injuries were reported as the administration had vacated it after declaring it unsafe. After the incident some other buildings in the vicinity have been vacated as they have developed cracks. Officials said around two weeks ago land-slide had rendered the building unsafe, as it had developed cracks and a retaining wall was also erected by the owner to save the building but fresh cracks were developed on Wednesday. They said on Thursday noon, the building was vacated along with other buildings in the surroundings. Urban development minister Suresh Bhardwaj visited the spot to assess the loss. He has directed the district administration to provide immediate relief to the affected families and also directed it to initiate probe into the reasons that led to the collapse of the building. Sources said multi storied buildings on steep slopes and sliding slopes due to fast leaching green cover have made Shimla city prone to natural calamity. The 14 major localities of Shimla are situated on average slope of 35 to 70 degrees with peak population density of 2,000 to 3,000 per hectare. Majority of localities in Shimla planning area with massive construction of buildings on slopes without adhering to the provisions of seismic building code and earthquakes resistance measures, are vulnerable to hazards. Localities like cemetery, Sarjauli, Jumu Colony, Chaalkar, Katchi Ghati and Lower Bhasuri are susceptible to major mishaps during earthquakes, triggering collapsing of buildings on slopes down below. Talking about the erstwhile Medical Council of India (MCI), he said that questions used to be raised on its decisions and there were allegations on its transparency. These had an adverse impact on quality of medical education and delivery of health services, the prime minister said.

The Centre worked on a national approach and a new national policy to transform the health sector, Modi said. "Health is a state subject and I know what difficulties are there, because I was also a chief minister. We worked on that. The problem here was that the health system was divided and there was a lack of connectivity and collective approach at the national level," he said.

Stressing on the need to spread the network of healthcare facilities across the country, he said it is very important to spread their network rapidly to every nook and corner of the country. "Today we can say with satisfaction that India is moving from six AIIMS (All India Institute of Medical Sciences) to a strong network of more than 22 AIIMS," he said.

ED confiscates ₹13cr of Chinese-owned personal loan app

PC Financial is a wholly owned subsidiary of Oplap Digital Services of Mexico which is a subsidiary of Tenoprest Ltd of Hong Kong, owned by Opera Ltd and registered in Cayman Islands, and Wisdom Connection Holding, which ultimately owned by Chinese national Zhou Yuhui.

New Delhi: The Enforcement Directorate's actions against Chinese apps operating in India continued with the agency confiscating another ₹13 crore in banks and various payment gateways this week on charges of alleged violations of Foreign Exchange Management Act, taking the total seizure in one case to more than ₹238 crore.

Earlier the agency had seized ₹397 crore on August 26 during an investigation against Chinese nationals operating illegal apps in India on micro finance. The PC Financial provides instant personal loans through its mobile application 'Cashloan' for suspicious foreign outward remittances, the agency claimed.

The Chinese national took illegal control of the Indian NBFI to operate in the micro finance domain. The beneficial ownership remained through a cross holding of shell firms registered in tax havens such as Cayman Island and Hong Kong. Investigation further revealed that the foreign parent company of PCFS brought FDI worth ₹113 crore for lending business," the ED said.

Amazon clarifies to govt on reported legal fee

New Delhi: Amazon has clarified to the government on its reported legal fee, saying the expense includes professional fee as well, according to sources. The clarification came after reports that Amazon spent about ₹500 crore or USD 1.3 billion in legal and professional expenses during 2019 in the country.

According to sources, Amazon has written to Commerce and Industry Minister Piyush Goyal, saying these reports are inaccurate and 'appear to stem from a misunderstanding of some filings, in particular a 'legal and professional expense' line item that includes substantial non-legal expenses.
