

- 1. Shareholders are requested to express their consent for holding the 20<sup>th</sup> (Twentieth) Annual General Meeting at a notice shorter than 21 days.
- 2. The Ministry of Corporate Affairs ('MCA') has vide its circular dated 25 September 2023 read together with circular dated 28 December 2022, 13 January 2021, May 5, 2020, April 8, 2020 and April 13, 2020 (collectively referred to as 'MCA Circulars') permitted convening the Annual General Meeting ('AGM') through Video Conferencing ('VC') or other Audio Visual Means ('OAVM') and that the physical presence of the shareholders/authorized representatives are not required at the scheduled venue. Accordingly, the 20<sup>th</sup> (Twentieth) AGM of the Company is being held through VC /OAVM.
- 3. Since this 20<sup>th</sup> (Twentieth) AGM is being held through VC/OAVM, physical attendance of the shareholders has been dispensed with. However, the authorized representatives of the body corporate shareholders attending the meeting through VC/OAVM is required to sign the attendance slip (annexed hereto) in respective counter parts.
- 4. Since the 20<sup>th</sup> (Twentieth) AGM will be held through VC/OAVM, the route map of the venue of the Meeting is not annexed hereto.
- 5. Shareholders/authorized representatives of the body corporate shareholders attending the AGM through VC / OAVM shall be reckoned for the purpose of quorum under section 103 of the Companies Act, 2013.
